Better Classrooms

New classrooms equipped with the latest technology in the area occupied by the Nathan Ross building, to be ready by autumn 2017 at a cost of £5 million.

An Upgraded Library

Increase the educational and vocational role that the library provides and integrate it with other advancements in learning technology.

Multi Use Spaces

New flexible spaces for drama, music rehearsals, performances and debating.

Better Pitches

Renovation of pitches at Almshouse Lane, new drainage and irrigation, to give us a premium facility by November 2015 at a cost of £300,000.

A Better Pool

Renovation of the current swimming pool at Shrewsbury House by December 2015 at a cost of £200,000. Longer term plans for a new pool complex.

A Better Clubhouse

Renovation and extension of the clubhouse at Almshouse Lane at a cost of around £1.5 million for completion in 2018. Longer term plans for a new sports complex.

Developing all our facilities



Better Access

Plans for new access roads for Shrewsbury House and Almshouse Lane to improve traffic flows. An investment of £1 million by autumn 2016.

Better Catering

Co-location of serving and dining areas, and a new kitchen.

Better Visitor Areas

New welcoming and attractive visitor areas accessed through the original front door.

Weekly Boarding

Re-introduction of weekly boarding on the first floor of our trophy Victorian building.

The reconfiguration of our main building at Shrewsbury House will require an investment of around £2 million and will be completed during 2018.
